

# Privacy Policy for Tents With Graphics, DBA under Promotional Design Concepts INC

## 1. Introduction

Promotional Design Concepts INC, doing business as Tents With Graphics ('we', 'our', 'us'), is committed to protecting your privacy. This Privacy Policy explains how we collect, use, disclose, and safeguard your information when you visit our website, [www.tentswithgraphics.com](http://www.tentswithgraphics.com) (the 'Site'). ## 2. Information We Collect

We may collect information about you in a variety of ways. The information we may collect on the Site includes:

- **Tracking Technologies:** We may use cookies, web beacons, tracking pixels, and other tracking technologies on the Site to help customize the Site and improve your experience. When you access the Site, your personal information is not collected through the use of tracking technology. Most browsers are set to accept cookies by default. You can remove or reject cookies, but be aware that such action could affect the availability and functionality of the Site.

## 3. Use of Your Information

Having accurate information about you permits us to provide you with a smooth, efficient, and customized experience. Specifically, we may use information collected about you via the Site to:

These vendors may use cookies and web beacons to collect information about your activities on the Site and other websites to provide you with targeted advertising based on your interests.
